- 1) Sukkur Electric Power Company (SEPCO) is a Public Sector Power Distribution Company registered under Companies Ordinance 1984. It is playing its role in "Pakistan's Economy" by supplying "Electricity" to the Houses, Commercial, Agricultural and Industrial Units of "Inhabitants" of "Upper Sindh" since August 2010.
- 2) **Method of Procurement:-**
SEPCO invites "Sealed Bids" on the basis of single stage two envelope procedure from national firms in order to develop and implement "ERP Solution" for SEPCO comprising the services / products as per detail given in the bidding documents.
- 3) **Availability of Bidding Documents:-**
A complete set of Bidding documents may be purchased by an interested bidder on submission of a written application to the undersigned on payment of **Rs: 5,000/- (Non-Refundable)** up to a day before Tender Opening Date, during office hours.
- 4) **Bid Security:-**
All bids must be accompanied by a Bid Security of 2% of the Bid Value in shape of Bank Draft / Pay Order in the name of **Chief Executive Officer SEPCO Sukkur**, issued by any Scheduled Bank of Pakistan in the form specified in the Bidding Documents alongwith the Sales Tax Registration Certificate.
- 5) **Submission of Bids:-**
The bids must be delivered to the office of undersigned upto **10:30 A.M** on **30-01-2017**. Any bid received after the indicated time shall be rejected. Conditional bid or bids without Bid Security shall not be accepted.
The bids shall be opened at **11:00 A.M** on the same day at SEPCO Head Quarter in the presence of bidders representatives who choose to attend.
- 6) **Bid Validity Period:-**
Bids will be valid for a period of (180) days.
- 7) **Pre-Bid Meeting:-**
SEPCO will arrange a Pre-bid meeting on **24-01-2017** in SEPCO Committee Room at **10:00 A.M**. All Bidders are requested to attend the said Pre-Bid Meeting. The purpose of meeting will be to clarify issues and answer questions on any matter that may be raised at this system, with particular attention to issue related to the technical requirements.
