ELIGIBILITY

2. This Invitation for Bids is open to all Bidders who meet out the following requirements/criteria.
 - a. PEC certificate renewed for the Year 2024-25.
 - b. The Bidder/JV must completed at least two (02) No. contracts that have been successfully completed alongwith completion certificate within the last Eight (08) years similar to above work.
 - c. Identity Card of Contractor/Managing Partner/Director of the firm or his authorized person.
 - d. Bidding documents will be issued only to the Owner or his authorized person having authority letter on Rs.100/- judicial stamp paper for receiving tender documents/participants in tenders.
 - e. All bid must accompanied with 3% of total bid price as bid security for each tender in the shape of CDR from any scheduled bank from their own Bank Account & must entered the name of firm on CDR in favour of Project Director GSC SEPCO Sukkur.
 - f. The difference of Call Deposit must be submitted alongwith tender documents at the time of submission of Bids, calculated on total offered Bid.
